This letter confirms receipt of your annual Declaration of Eligibility (DOE) Affidavit and supporting documentation. The Indiana Department of Transportation's Equity Initiative Services (EIS), in compliance with 49 CFR Parts 23 and 26, is pleased to inform you that your firm's information has been reviewed and approved. Failure to apply for an amendment and increase in scope of work may result in forfeiture of DBE Credit at the time of letting. Work may result in a forfeiture of DBE Credit at the time of letting.

Your firm's DBE/ACDBE Certification will remain valid for another year.

The DBE Directory, located at INDOT: Doing Business with INDOT: DBE Directory, will continue to list your contact information and will include the NAICS codes, Jurisdiction of Eligibility (JOC) date and description of services performed. Please review your current entries.

To maintain your DBE status, you must notify INDOT immediately of any change in location or contract information, including an update email address. You must also inform INDOT in writing of any change in circumstances affection your ability to meet size, disadvantage status, ownership or control requirements or any material change to the information provided in your application.

The information above must be received by INDOT within seven business days of the change. Failure to do may result in revocation of your firm's certification. If you have any questions, please feel free to contact us at ElSinquiry@indot.in.gov atany time.

The Declaration of Eligibility (DOE) form is required each year in order to verify your business continues to meet the standards required in the DBE/ACDBE program. The DOE will be available 60 days before the due date. The DOE is due the last day of your certification month. Failure to complete will result in the suspension of your certification.

We suggest you note the DOE due date on your calendar.
